Photoshop has more features than you can shoot a bullet through. The first thing to know when using Photoshop is that you can't turn it on and start using the program without getting a thick book with every imaginable tool and feature to learn, one after the other. For example, a beginner could learn the paint bucket tool, then move on to the rectangle tool, and then get into a slide show that rambles on with the individual brushes, gradient tools, patterns, and the like. Photoshop comes with a lot of features. When you open Photoshop, you see many things that look similar to the Paintbox. Most of these tools can be found on the same tool bar and, at the bottom of the application, you see the Paths tool and the Drop Shadow box. If you click the tab that says Photoshop, you see that the Tool options are divided into two parts, one for WYSIWYG (what you see is what you get) editing and the other for creating images from scratch. That's what you will see in most of the chapters in this book. You may not see exactly what I say in terms of how to open an image, but you will see a basic understanding of how to open an image in Photoshop. Although this book focuses on the desktop version of Photoshop, the graphics editing software has many different versions. The versions you can find for computers include Photoshop CS2, Photoshop CS3, Photoshop CS4, Photoshop CS5, Photoshop CS6, and Photoshop CS6 Extended. I use Photoshop CS6 in this book because it's the latest version available when this book went to print. Deleting an object Many of us think when we need to delete an object we place that object in the trash or in the Recycle Bin. Deletions in your graphics are usually done the same way. However, Photoshop actually has two methods for deleting an object: you can either cut the object out of the image or, if you have the object selected, you can delete it. You can use the Delete Object tool.

For example, to cut out an object, select the object and the tool, and then click the image area where you want to place the object. You see a box that says Select Similar

How do I use Photoshop Elements? Elements is easily installed and easy to use. You need to have some form of Internet connection to complete the first steps of installing Photoshop Elements. Even when you do not have Internet access, you can view most of the steps. You can browse for a CD or DVD of the latest version of Photoshop Elements or search for the version you prefer on the Internet. Once you are connected to the Internet, you will start by creating an account. You will start by browsing for the version of Photoshop Elements you need and selecting it for installation. Jeffers*, 810 F.2d at 725. The SBA argues that BancorpSouth's financial statements demonstrate its inability to fund the alleged default in light of the 2008 financial crisis. Yet, those financial statements were submitted to the SBA in 2008 in an effort to obtain financing to purchase the Bank, and the SBA therefore had a copy of BancorpSouth's statements in 2008. The SBA also argues that the Bank's investment in the notes demonstrates its inability to fund the alleged default; however, the Bank did not incur any losses on the notes, and the notes were not issued by a major financial institution. See *Sea Cept*, 831 F. Supp. 2d at 228 (noting that the plaintiff's investment in the assets of the underlying defendants supported a finding of inability to pay). Finally, the SBA argues that the finding of the bankruptcy court that the Barone plaintiffs and their counsel held a secret interest in the Bank and its purchase should be binding, as the Bankruptcy Court granted the Bank relief from automatic stay in order to obtain these interests.
