While the FBI and Department of Justice has been hit with a lawsuit for ignoring security notices for as long as three years, many of us have warned that this is symptomatic of a larger disease that permeates the government. When the lawsuit was filed Monday in federal district court, a law firm representing Pamela O'Neal and her husband Bill O'Neal described the defendants as "federal government agencies that have (1) monitored email on the O'Neals' and friends' (or family's) computer(s) without prior judicial authorization; (2) intercepted private communication and placed sensitive information in the National Archive and Record; and (3) exposed, and continue to expose, the O'Neals to an imminent threat of serious bodily harm, death, and destruction of their home and family." Due to the extent of the lawsuit, the FBI and DOJ are not discussing the nature of the suit in detail, but according to court documents, the plaintiffs have requested "(1) a declaration that the FBI's electronic monitoring is a violation of the Fourth Amendment of the United States Constitution; (2) an injunction prohibiting the defendants from engaging in such illegal activity; and (3) reasonable attorneys' fees and

The court filing asserted "Defendants' repeated violation of the O'Neals' Fourth Amendment rights for almost three years has resulted in a continuing invasion of their right to be free from unreasonable searches and seizures. The O'Neals are being subjected to a continuous invasion of their right to privacy by the Defendants." The suit also stated that "Defendants have engaged in an ongoing pattern of intentional harassment and intimidation of the O'Neals and their lawyers, in furtherance of their goal to deny the O'Neals' due process rights
